

**INVITATION TO BID**  
**Furnish And Install An Emergency Generator For Courthouse**

The Baker County Board of County Commissioners is seeking sealed bids from qualified General or Electrical contractors to provide labor, materials, supplies, services, etc to provide and install a first-time generator set in the Baker County Courthouse, located at 339 E. Macclenny Ave, Macclenny FL 32063. The County Courthouse has been designated a building of historic significance, therefore the proposed generator plan must be approved by the Baker County Historical Society prior to commencement of work.

The County is seeking a lump sum price for a turn-key project. Estimated cost of project \$115,000-120,000.

**MANDATORY PRE-BID CONFERENCE will be held on December 13, 2018 at, 10:00 a.m. local time. Bidders are required to attend to be eligible to bid on the project. This project requires Performance and Bid Bonds to be provided. This meeting will be held at the Baker County Administration Offices located at 55 North Third Street, Macclenny, FL 32063.**

Bid will be received until 3:00 p.m., December 20, 2018 in the Office of the County Manager, Baker County Board of Commissioners, 55 N. 3<sup>rd</sup> Street, Macclenny FL 32063. **Bid MUST have the respondent's name and mailing address clearly shown on the outside of the envelope or package when submitted.** Submit two (2) copies of your bid in a sealed envelope or similar package marked **“GENERATOR FOR COURTHOUSE”** on the front of the envelope.

The deadline to submit questions is December 18, 2018, at **10:00 AM**. All answers will be issued in writing via addendum on the County's website.
