

INVITATION TO BID
BID 2020-01

The Baker County Board of County Commissioners is seeking sealed bids from qualified General Contractors to fully renovate the building and extend the width the building by one-third at Fire Rescue Station 30 in the Cuyler Community. The work involves extending a space to the far left of the building approximately 18' x 48' to add a community room and additional crew quarters, and includes walls, framing, roof, electrical, and other materials that match the existing structure to make the new extension look part of the original construction. The successful contractor must develop a plan/design for the project that is stamped by an engineer registered with the State of Florida. The County is seeking a lump sum price that includes construction, plans, design, permits, etc. for a turn-key project. Estimated cost of project \$130,000.

MANDATORY PRE-BID CONFERENCE will be held on February 20, 2020 at, 9:00 a.m. local time. Bidders are required to attend to be eligible to bid on the project. This project requires Performance and Payments Bonds to be provided. This meeting will be held onsite at 19145 CR 125 N, Sanderson, FL 32087.

Bid will be received until 11:00 a.m. on February 28, 2020, in the Office of the County Manager, Baker County Board of Commissioners, 55 N. 3rd Street, Macclenny FL 32063. **Bid MUST have the respondent's name and mailing address clearly shown on the outside of the envelope or package when submitted.** Submit two (2) copies of your bid in a sealed envelope or similar package marked **"RENOVATE AND EXTEND FIRE RESCUE STATION 30"** on the front of the envelope.

Bids will be opened, and respondents announced at 11:00 A.M. local time, or as soon thereafter as practical, on February 28, 2020, in the Baker County Administrative offices, 55 N. 3rd Street, Macclenny FL 32063. The bid opening is open to the public.


