1	Failure to vaccinate against rabies [by a licensed veterinarian F.S. 828.30]	\$30.00
2	Rabies vaccination fee [100% of this fee to paid to veterinarian]	\$20.00
3	Animal at-large [Includes paying the fine and redeeming the dog]	\$30 – Already microchipped \$35 – No microchip. Requires mandatory microchip to redeem dog. \$55 – 2 nd occurrence and after
4	Failure to confine cat or dog while in heat [Code section 6-27(c)]	\$30.00
5	Annual Fee for keeping animal with classification of dangerous dog. Payable on day of registration and annually thereafter.	\$250.00 [Includes annual inspection by Animal Control and microchipping]
6	Failure to confine/restrict dangerous or vicious animal [dangerous defined in Code 6-56]	\$100.00
7	Unlawful luring, enticing, teasing and harassment of an animal [Code section 6-29]	\$55.00 - 1 st occurrence \$105.00 - 2 nd occurrence & after
8	Livestock at large (Fine is per animal) [Includes paying the fine and redeeming the animal]	\$55.00
9	Receiving Fee for personal adult animal (over 5 months) [Owner surrender]	\$15.00 each animal
10	Receiving Fee for litter of puppies or kittens (6 or less) [Owner surrender. Must be 8 weeks old, already have worming, parvo or kitten booster shots.]	\$15 per litter
11	Receiving Fee for litter of puppies or kittens (7 or more) [Owner surrender. Must be 8 weeks old, already have worming, parvo or kitten booster shots.]	\$25.00 per litter
12	Adoption Fee for cats/kittens [\$50 Fee goes to veterinarian for spay/neuter, worm, rabies. \$5 to Electronics Admin fee]	\$55.00
13	Adoption Fee for dogs/puppies [\$65 fee goes to veterinarian for spay/neuter, worm,	\$90.00

	rabies; \$20 goes to County; \$5 to Electronics Admin fee;]	
14	Found dog with unknown ownership	No charge
15	Euthanasia at owner's request - at County facility	\$25.00
16	Euthanasia at owner's request – owner's location	\$35.00
17	Euthanasia of livestock – owner's location	\$100.00
18	Tranquilizer fee - per 3 cc dose [Used: 1) To humanely catch a dog at large when other means have been exhausted, or 2) when requested by owner, to calm the dog during euthanization.]	\$15.00 Note: tranquilizer drugs are for dogs only.
19	Tranquilizer fee - per 5 cc dose [for extremely large dogs]	\$25.00
20	Board Fee – per night. [applies to business days only Mon-Fri]	\$10.00 per night
21	Mandatory Quarantine (10 day observance) [Florida Dept of Health Draft 64D-3, F.A.C Extract Rabies Prevention and Control; and Baker County Code Section 6-32]	\$100.00 [This is 10 days board fee @ \$10/day]
22	Deposit for placing animal traps on property. (Refundable deposit)	\$50.00 per trap

Holding Periods:	
City of Macclenny [Macclenny code section 5-36] = 5 days	
Stray animals [owner unknown] = 1-5 days, depending on health status	
Owned animals with identification = 10 days (boarding fee applies)
