State Housing Initiative Partnership (SHIP)



MONEY stretched so tight you just can't pay for those needed repairs to bring your house up to code? Find out hour the SHIP Program can help with your repairs.

Eligible very low- and low-income applicants can apply for funding assistance to meet the costs of needed repairs.

WHAT IS REHABILITATION ASSISTANCE?

The Owner-Occupied Rehabilitation Strategy provides needed code related repairs to the homes of eligible county residents. Through this program, substandard housing conditions are corrected to improve the health, safety, welfare, and accessibility of the occupants.

HOW WILL THE LOAN BE REPAID?

Funding assistance is offered as a 0% interest, deferred payment loan for 15 years. Payment in full is required should the homeowner sell, rent, lease, demise or otherwise vacate the residence.

HOW DO I QUALIFY?

- Applicants must apply to the SHIP Program via "Neighborly" on the Baker County SHIP website.
- Total household income must not exceed Florida Housing Finance Corporations Low Income limits for the SHIP Program (see chart on next page).
- Homes must be located in unincorporated Baker County.
- Applicants must be current on county property taxes and any existing liens on the property.
- Repairs cannot exceed 60% of structure's appraised value.
- Property must be in name of applicant(s) evidenced with a fully executed and recorded deed.
- Home must be the primary, homesteaded residence of the homeowner.

The rehabilitation strategy addresses code related issues only. County inspection will determine the need for rehabilitation and the maximum amount of assistance to be provided. Should your home be determined beyond the scope of the rehabilitation strategy, you may want to apply for the Demolition/New Construction strategy.

*If you do not qualify for SHIP, there are other programs which may be able to assist you with repairs to your home if you qualify. Please contact them directly for eligibility determination.
